# University of Illinois Fire Service Institute Course Syllabus

Course Title: Community Risk Reduction Awareness

Course Duration: 8 hours

**Program:** Prevention and Inspection

Course Prerequisites: None

Course Description: CRR is not a new concept for the fire service. For years fire departments have been involved in some form of community risk reduction through building inspections and public education since they were first organized in the U.S. But this concept needs to be applied in a focused manner, and truly integrated into the mission of the fire department. The process of CRR often unfolds in a predictable sequence of: (1) identifying fire risks at the operational level (preferably by fire station response area); (2) prioritizing the risks to be addressed, and (3) coordinating elements of emergency response with preventive tactics that mitigate risks. Applying CRR affords U.S. fire service agencies the opportunity, through a systematic approach, to proactively manage the risks within their communities.

#### **Course Requirements and/or Recommendations:**

Pre-Course Work – None Course Work – Attend and participate in all course lecture and activities. Post-Course Work – None

These can be divided into three categories: those completed prior to arriving in class (Pre-Course Work), those completed during class, such as homework assignments and quizzes (Course Work), and requirements completed after class but prior to receiving a certificate of completion.
