Course Title: Acquired Structure Burn

Course Duration: 8 hours

Program: Fire Fighting

Course Prerequisites: None

Course Description: An acquired structure burn is a unique opportunity for fire fighters to learn new skills, as well as, to hone previously acquired abilities. As a result, this course has been designed for fire fighters of every background, training and experience level. The course is appropriate for any volunteer, paid-on-call, or career fire department member. Topics covered will include fire behavior, hose movement, ventilation techniques, search and rescue, fire attack, and coordinated fire attack. Drills and scenarios will be customized to match the resources and personnel available. There may be instances where all topics are not covered due to structure, equipment, and/or personnel limitations.
